

Council Chair Terry Eggum called the meeting to order at 5:55 pm and opened in prayer. Thanks to all who helped with Phil Christman's service and for those who helped with the highway clean-up.

ADDITIONS TO THE AGENDA: End-of-year campaign, gift card for Pastor Tom Summerfield

M/M/S by David Moore/Jim Martineau to approve the minutes of the October 8, 2024 meeting. Motion carried.

TREASURERS'S REPORT: M/M/S by Ruth Eggum/Peg Osmundson to approve the Treasurer's report for October, 2024 for audit. Motion carried. Copies of the Proposed Budget for 2025 were distributed. This will be approved by the Council at the December meeting. Mike O. will ask Beth Smuk if she will do the audit for 2024. Mike O. reported that Nancy Christenson has applied for a \$500 Beautification Grant to help with the cost of repairs to the church building.

<u>DIACONATE REPORT</u>: Ruth Eggum reported we accepted with regret Agnes Gilson's resignation. Jim Martineau will check with Lee Martineau, who does forging, if he is able to make name plates for the Memorial Board. (Mike O. stated that there is a company in St. Cloud who also does this work.) We will sponsor a Christmas party for the House of Love and send a card signed by the congregation. We will decorate the church for Christmas on November 26 at 1:00. The Christmas Eve service this year will be congregation-led, rather than getting pulpit supply.

TRUSTEE REPORT: Mike Osmundson reported that Mike Tarolli has finished the work on the front of the church and the windows. M/M/S by Terry Eggum/Peg Osmundson to hire Stack Brothers of Superior, WI to look at the retrofit controls and timer on the church's boiler/furnace and come up with a plan for maintenance at the cost of up to \$1,000.

CHRISTIAN ED REPORT: Game Night was held on October 25 and they plan to have another in the spring.

<u>PASTOR TRANSITION UPDATE:</u> Paula Holden and Amy Wasson of the Search Committee have sent information and the church profile out to the five denominations. A friend of Amy Wasson took drone photos of the church building which may be included in the church profile.

<u>OLD BUSINESS</u>: Dedie Moore reported that she is keeping up with Tabitha Ministry contacts. <u>NEW BUSINESS</u>: The Chair-Elect needs to be named and begin shadowing Chair Terry Eggum in January 2025. The new Chair's term would be January 2026-2028. We will put a notice in the bulletin asking for anyone interested in this position. There was discussion on whether or not to compensate the drone operator for his photographs. This was tabled till the December meeting. The end-of-year campaign letter needs to go out in December, but we need a sample copy from past years. Terry Eggum will contact Pastor Paul to see if he has any old ones. M/M/S by David Moore/Ruth Eggum to get Pastor Tom Summerfield a \$50 Four Seasons gift card for helping the church out with Phil Christman's service. Brenda Larson will pick up the gift card and Lynn Anderson will make a thank you card.

Parish Nurse Notes Dedie Moore Retired R.N.

December is Seasonal Affective Disorder awareness month. It is common to go through short periods when one feels sad and has less energy. Many people get the "winter blues" as days shorten. These mood changes can become more serious and affect how one feels, thinks, and functions. For some, this happens in the summer, although this is less common. SAD is a type of depression with a recurrent seasonal pattern lasting 4-5 months.

Symptoms may include:

Persistent sad, anxious or "empty" mood most of the day, nearly every day for at least two weeks

Feelings of hopelessness or pessimism

Irritability, frustration, restlessness

Feeling guilty, worthless or helpless

Oversleeping or difficulty sleeping

SAD is different from the "holiday blues" --depression related to certain occasions.

SAD can be treated by light therapy, exercise, psychotherapy, vitamin D or medication. SAD can also respond to the daily practice of taking 5 minutes 2 or 3 times a day to concentrate on moments of joy in your life, present or past. Keep a list of joy moments, usually shared with others, and revisit these regularly.

C Calm, learn to calm yourself

A Appreciate, practice gratitude

K be Kind to those you contact

E make eye contact
